Freight Payment Terms & Conditions

1. Kaiser Transport, Inc. agrees to provide truck transportation for shipper/customer/broker and shipper/customer/broker agrees to pay the agreed legal rates and charges of Kaiser Transport, Inc. per confirmation.
2. Kaiser Transport, Inc. represents that it holds the required motor carrier operation authorities necessary to respond to shippers'/broker/customer transportation requirements. Kaiser further represents that it is in compliance with the various rules and regulation applicable to it, as a regulated motor carrier of freight.
3. Shipper/customer/broker shall pay Kaiser Transport, Inc. invoices within thirty (30) days of receipt of Kaiser's freight bill. Kaiser bills daily and it shall be assumed that the shipper/customer/broker receives Kaiser's freight bills no later than three (3) days after the date of such invoicing.
4. If freight bills are not paid within the period set forth in paragraph (3) above, then Kaiser shall assess shipper/customer/broker a late charge of 1.5% per month on any balance due and shipper/customer/broker agrees to pay the same.
5. Notwithstanding, otherwise applicable rules and regulations, shipper/customer/broker agrees that Kaiser shall not be foreclosed by a "non-recourse" provision in the shipper's bill of lading from collecting the freight charges from shipper where C.O.D. charges are not paid on delivery or through the submission of Kaiser freight bill to the consignee or party otherwise responsible for C.O.D. payment. Should Kaiser be unable to collect C.O.D. charged from the consignee or other responsible party, shipper/customer/broker agrees to pay such charges within thirty (30) days of Kaiser's written notice of it's inability to collect such charges, if Corporation or LLC, shipper/customer/broker hereby gives personal Guarantee for all freight bills whose signature appears below.
6. Kaiser reserves the right to exercise the carrier's lien on freight set forth in civil code S 3051.S and shippers/customer/broker failure to timely pay billed charges may result in a lien on future shipments including cost of storage and appropriate security.
7. No amendment of modification of agreement shall be binding unless executed in writing by the party to be bound thereby and made in accordance with the requirements of any government agency having jurisdiction of the matter.
8. In the event either party finds it necessary to resort to litigation to enforce the rights under this agreement, the prevailing party shall be entitled to an award of reasonable attorney's fees.
